





Taxation system in Ukraine

Corporate income tax (CIT) – **18%** Single Social Tax (SSC) - **22%** Income Tax (ITAX) - **18%** Value added tax (VAT) - **20%**

Withholding tax (dividends, interests, royalties) - **15%**

Commercial and industrial land – **no restrictions** Municipal property – restrictions for **non-residents** Agriculture land – moratorium for sale **till 2018**


